# **Your Privacy**

Radio Maria Lithuania follows all legal requirements to protect your privacy. You must be agree to our privacy policy before downloadn and Install our app. Our Privacy Policy is a legal statement that explains how we may collect information from you, how we may share your information, and how you can limit our sharing of your information.
