

Radio Maria Nicaragua- Privacy Policy Last update – March 2017

It governs the privacy terms of our app RADIO MARIA Nicaragua by Emaxlab and Website, located at <https://www.radiomaria.org.ni>. Any capitalized terms not defined in our Privacy Policy, have the meaning as specified in our Terms of Service.

Your Privacy

Radio Maria Nicaragua follows all legal requirements to protect your privacy. You must be agree to our privacy policy before downloadn and Install our app. Our Privacy Policy is a legal statement that explains how we may collect information from you, how we may share your information, and how you can limit our sharing of your information. You will see terms in our Privacy Policy that are capitalized. These terms have meanings as described in the Definitions section below.

Definitions

“Non Personal Information” is information that is not personally identifiable to you and that we automatically collect when you access our Website with a web browser. It may also include publicly available information that is shared between you and others. “Personally Identifiable Information” is non-public information that is personally identifiable to you and obtained in order for us to provide you within our Website. Personally Identifiable Information may include information such as your name, email address, and other related information that you provide to us or that we obtain about you.

Information We Collect

Generally, you control the amount and type of information you provide to us when using our App. As a Visitor, you can browse our website to find out more about our Website though our app. You are not required to provide us with any Personally Identifiable Information as a Visitor.

Computer Information Collected

When you use our Website, we automatically collect certain computer information by the interaction of your mobile phone or web browser with our Website. Such information is typically considered Non Personal Information. We also collect the following:

Cookies

Our Website pages uses “Cookies” to identify the areas of our Website that you have visited. A Cookie is a small piece of data stored on your computer or mobile device by your web browser. We use Cookies to personalize the Content that you see on our Website. Most web browsers can be set to disable the use of Cookies. However, if you disable Cookies, you may not be able to access functionality on our Website correctly or at all. We never place Personally Identifiable Information in Cookies.

Automatic Information

We automatically receive information from your web browser or mobile device. This information includes the name of the website from which you entered our Website, if any, as well as the name of the website to which you're headed when you leave our website. This information also includes the IP address of your computer/proxy server that you use to access the Internet, your Internet Website provider name, web browser type, type of mobile device, and computer operating system. We use all of this information to analyze trends among our Users to help improve our Website.

Third Party Services

Radio Maria World Family does not intend to transfer Personal Information without your consent to third parties who are not bound to act on Radio Maria Nicaragua behalf unless such transfer is legally required. Similarly, it is against Radio Maria Nicaragua policy to sell Personal Information collected online without consent.

Your Consent

By using this Web site, you consent to the terms of our Online Privacy Policy and to Radio Maria Nicaragua processing of Personal Information for the purposes given above as well as those explained where Radio Maria Nicaragua collects Personal Information on the Web.

Information security

We take appropriate security measures to protect against unauthorized access to or unauthorized alteration, disclosure or destruction of data. We restrict access to your personally identifying information to employees who need to know that information in order to operate, develop or improve our services. Updating your information We provide mechanisms for updating and correcting your personally identifying information for many of our services.

Children

Radio Maria Nicaragua will not contact children under age 13 about special offers or for marketing purposes.

Information Sharing and Disclosure

Radio Maria Nicaragua does not rent, sell, or share personal information about you with other people (save with your consent) or non-affiliated companies except to provide products or services you've requested, when we have your permission, or under the following circumstances. We respond to subpoenas, court orders, or legal process, or to establish or exercise our legal rights or defend against legal claims; We believe it is necessary to share information in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of Radio Maria Nicaragua terms of use, or as otherwise required by law.
